Canada issues two types of travel documents: the refugee travel document and the certificate of identity. They are issued to residents of Canada who are convention refugees, protected persons, and stateless persons. They are also issued to permanent residents who can't get a national travel document for a valid reason.

Apply for a travel document in Canada - Non-Canadian ...

Convention refugees and protected persons can use a Refugee Travel Document (RTD), issued by the Passport Canada, in order to exit and re-enter Canada. A protected person who is not a permanent resident and who intends to travel outside Canada must obtain an RTD from the Passport Office before leaving Canada by submitting an Adult Travel Document Application (PPTC 190) or a Child Travel Document Application (PPTC 192).

Refugee travel document - Refugees and Protected Persons ...

you will need a Refugee Travel Document. To apply, you will need to give Passport Canada proof of your status in Canada. You will need either: a letter from the Immigration and Refugee Board (IRB); a confirmation of permanent residence; or; a Verification of Status (VOS) document. If you are a Convention refugee, you should have a letter from the IRB.

Refugee travel document. : issued to persons in Canada with protected person status, including Convention refugees and persons in need of protection. Certificate of identity. : issued to permanent residents of Canada who are not protected persons and who are stateless or are unable to obtain a national passport.

Permanent residents returning to Canada by airplane, boat, train or bus must show a valid Permanent Resident Card (PR card) or Permanent Resident Travel Document (PRTD) before boarding. Use this application if you are outside Canada, you have lost your PR card and you need proof of your status to return to Canada.

Refugee travel documents issued by the Government of Canada cannot be used for travel to the bearer's country of citizenship, and a refugee travel document issued by another country is not treated as a valid passport for the purposes of obtaining an Electronic Travel Authorization to visit Canada.

If you have a valid Canadian Refugee Travel document, you are exempt from both the visa and eTA requirements. A Travel Document is a document issued by Passport Canada to those with protected status, such as Convention Refugees and other protected persons. A Certificate of Identity is for those stateless persons who are in Canada legally, but who are not refugees or other protected persons; for example, Canadian Permanent Residents who are stateless.
