The mobile device is primarily a business tool and its use must comply with all requirements of the policy as outlined below as well as any additional applicable policies and procedures.

Mobile Device Usage Policy

Scope: The cell phone usage policy applies to all employees, managers and supervisors. Excessive use of a cell phone for personal reasons while at work is not allowed. Excessive use may include disruption of colleagues, a distraction from work tasks or causing accidents or problems due to using a cell phone where phones are not allowed or inside a company vehicle.

POLICY: Employees may use their Hospital-issued cell phone for personal use as long as the phone is used primarily for business and the usage does not exceed the monthly fee that is paid by the Hospital. All Hospital-issued telephones are the property of the Hospital.
