A special enrollment period is a set amount of time outside of the open enrollment period (which is typically around November 1 to December 15) where you can make changes to your health plan, including your FSA contributions.

FSA enrollment periods and qualifying life events ...

Enroll within 60 days of your start date — and prior to October 1 — of any benefit period. Qualifying Life Event Enroll or change your FSA election due to a qualifying event (PDF) as defined by the IRS.
