### **Health Care Assistance - Maine**

All income is based on gross monthly income; that is before any deductions are taken. Income to be counted includes all sources of income such as Social Security, pensions, profits from investments and interest earned. Asset limits for all programs are \$50,000 or less for and individual or \$75,000 or less for a couple.

In Maine If you are single and your income is less than \$1759 a month you may get help. If you are married and your income is less than \$2369 a month then you may get help. If only one person in a couple wants the help, then the income limit may be as high as \$2837 per month.

### **QMB Quimby | Maine Medicare Options**

Make note, Maine is unique in that the state allows a single individual an exemption of \$8,000 in liquid assets and married couples an exemption of \$12,000. (Liquid assets include checking and savings accounts). These amounts are in addition to the Medicaid asset limit of \$2,000 for a single individual and \$3,000 for a married couple.
