Form I-9 Acceptable Documents. Employees must provide documentation to their employers to show their identity and authorization to work. The documents on List A show both identity and employment authorization. Employees presenting an acceptable List A document should not be asked to present any other document.

## **Form I-9 Acceptable Documents | USCIS**

To have a U.S. passport, you need to be a U.S. citizen by birth or naturalization or be a U.S. national. Passport Book and Passport Card. Depending on where you are traveling outside of the U.S., you will need to determine if you need a passport book or a passport card. A passport book is required for all international travel by air.

## **Getting or Renewing a U.S. Passport | USAGov**

A utility bill, bank statement, government check, paycheck, student housing statement/tuition bill, homeless shelter occupancy statement, lease, or other government document that shows your name and address. If you're not voting for the first time in Washington DC, you don't need to provide ID to vote by mail.
